Provide an explanation, if necessary: ExTex LaPorte Limited Partnership currently has four generation facilities under Registration Number 20053 (listed as the Handley Facility, Mountain Creek Facility, LaPorte Facility, and Wolf Hollow I LP). As a result of a reorganization and divisive merger related to ExTex LaPorte Limited Partnership, each facility is now owned by a separate limited liability company. Specifically, the LaPorte Facility is now owned by LaPorte Power, LLC. The Handley Facility is now owned by Handley Power, LLC. The Mountain Creek Facility is now owned by Mountain Creek Power, LLC. The Wolf Hollow I LP facility is now owned by Wolf Hollow I Power, LLC. Accordingly, ExTex LaPorte Limited Partnership requests that the current registration be amended to assign LaPorte Power, LLC to Registration Number 20053, and three new registration numbers be assigned to Handley Power, LLC, Mountain Creek Power, LLC, and Wolf Hollow I Power, LLC.


