**ORDER NO. 3
ADDRESSING SUFFICIENCY AND NOTICE,
ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's recommendation regarding sufficiency of the application and notice of Rayburn Country Electric Cooperative (Rayburn) to amend its certificate of convenience and necessity for a proposed 138-kV transmission line in Fannin and Hunt Counties.

I. Application Sufficiency

On February 5, 2018, Commission Staff filed comments stating that Rayburn's application is sufficient and complete as filed. Consistent with Staff's recommendation, Rayburn's application is deemed sufficient and materially complete.

II. Notice

According to Commission Staff's recommendation, Rayburn has complied with Commission rules regarding published notice and notice sent to affected landowners, neighboring utilities, and county and municipal officials. Consistent with Staff's recommendation, Rayburn's provision of notice is approved.


III. Procedural Schedule

Commission Staff's recommendation included a proposed procedural schedule. The following procedural schedule is approved and shall apply to this proceeding:

If applicable, administrative review completed - 80 days from date of filing	March 26, 2018
